The specificity of each primer solution of the HLA-B*78 primer set has been tested against 48 well characterized cell line DNAs.

No DNAs carrying the alleles to be amplified by primer solution 4 was available. The specificities of the primers in primer solution 4 were tested by separately adding one additional 3'-primer, respectively one additional 5'-primer.

Results: No false positive or false negative amplifications were obtained.
